As an insurance professional, Mr. Clauser will receive customary commissions and other related revenues from the various insurance companies whose products are sold. Mr. Clauser is not required to offer the products of any particular insurance company. Commissions generated by insurance sales do not offset regular advisory fees. This practice presents a conflict of interest in recommending certain products of the insurance companies. Clients are under no obligation to implement any recommendations made by Mr. Clauser or the Advisor. Mr. Clauser spends approximately 20% of his time per month in this capacity.
